In the event of resale of goods purchased from Otis, Buyer shall include corresponding language in the agreement covering such resale, may not modify Otis warranties and shall make no other representations or warranties concerning the goods sold by Otis.

Returns: 20% restock fee shall apply, product shall not be returned without authorization. Disputes shall be addressed within three (3) week receipt of order. Please contact 1-800-Otisgun for return authorization.

<u>U.S. Consumer Products</u>: Certain Otis products, such as gallon sizes of O85 Ultra Bore may not be sold to individual consumers. Buyer agrees not to re-sell any such products to individual consumers and to include a warning to its customers that such products may not be re-sold to individual consumers.
